I will run those, and repeat the process. When you are called, give your full call, name, and location, followed by your listing. PLEASE speak slowly, and clearly. With conditions as they are, hearing can be tough. Please list one item at a time, REMEMBER, I have to write all this down. Listings are restricted to no more than 3 items per week. We request that each listing be kept to a minimum; to

include only the brand name, model number, (What it is, I.E. transceiver, receiver, Amp, ETC.), condition, price, and contact information. Please no history or sales pitch you can discuss this with the individuals when they contact you.

This net follows the guidelines and procedures set forth by the FCC Part 97, Paragraph (197.113 (A) (3).
